MOTOR VEHICLE SERVICE PROVIDER AGREEMENT
AMENDMENT No. 1

THIS AGREEMENT is made and entered into pursuant to the provisions of Section 66-2-14, NMSA 1978 by and between the State of New Mexico, Taxation and Revenue Department (TRD), Motor Vehicle Division (MVD) and SafetyNet Works, Inc. (Provider).

IT IS MUTUALLY AGREED BETWEEN THE PARTIES THAT THE FOLLOWING PROVISIONS OF THE ABOVE-REFERENCED CONTRACT ARE AMENDED AS FOLLOWS:

11. TERM AND CONDITIONS OF AGREEMENT TO EXTEND

11.1 This Agreement shall be for a term of three (3) years with the option to automatically renew for three (3) additional years not to exceed eight (8) years total under this agreement commencing from the date when all required signatures and approvals are obtained and affixed, unless a different date is specified.

11.2 Under this Agreement, the Provider shall upload and update Bond/Insurance coverage and Business License information in their MyMVD account no later than thirty (30) days prior to expiration of Bond/Insurance and Business License and regardless of the expiration date, complete the annual recertification process in their MyMVD account and/or as determined by TRD/MVD.

All other articles of this contract remain the same including termination under Paragraph 12.
